In a period of rapid changes, the most qualified profiles must be able to be recognized for their real value and actual competence; the Doctor of Professional Studies (DPS) responds effectively to this new need. Unlike any other traditional university programs, Selinus University's DPS by Research does not consist of any

coursework, classes or lectures to attend, either on campus or online. Rather, it is based on a Project Work that the candidate has to carry out autonomously on a specific professional topic among the available faculties of Selinus Universities.

The Doctor of Professional Studies (DPS) certifies the skills acquired by the candidate, as shown by his/her career and Project Work.



The program has no minimum duration, whereas a maximum duration of 18 months. Since it does not have any intake or admission deadline, students can apply any time of the year.

The main requirement for a Doctor of Professional Studies by Research is to carry out a Project Work, having a minimum length of at least 90/100 pages. It can be a technical, scientific or business essay, or even an academic thesis, on a topic of choice related to the candidate's background.

How to apply for the Doctor of Professional Studies

In order to be eligible for Selinus University's DPS by Research, any candidate must be at least 30 years old.

The final and total cost of the Doctor of Professional Studies program is € 2250 (two thousand two hundred fifty euros) and it is all-inclusive: ongoing student support, general supervision and evaluation of the Project Work, issuance and shipment of the certificates, authenticated via Blockchain technology.

In case the application is accepted, our Secretariat will send via email the Acceptance Letter, the Enrollment Certificate and the Payment Plan chosen by the candidate.

Being a professional title, The Doctor of Professional Studies (DPS) does not require any defense of the final Project Work, even if structured as an academic thesis.

To promote global access to study, Selinus University has minimized the cost of its programs, even without receiving any economic or financial contribution from public or third-party institutions. Therefore, no scholarships or discounts whatsoever are provided.

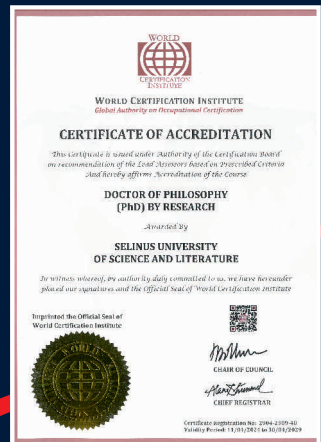
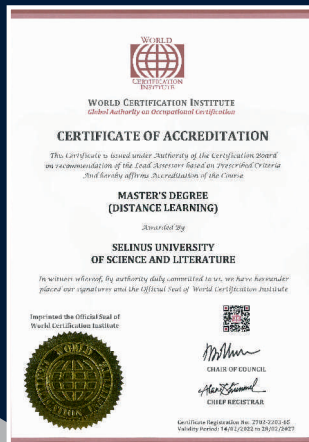

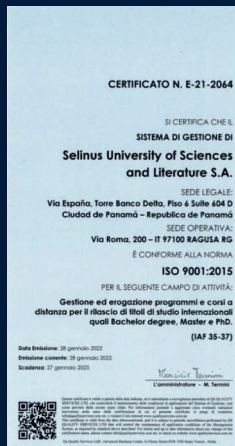
Since December 2022, it is also certified **ISO 29990** as an international university that offers career-focused study programs via distance learning for Bachelor's, Master's and PhD degrees.

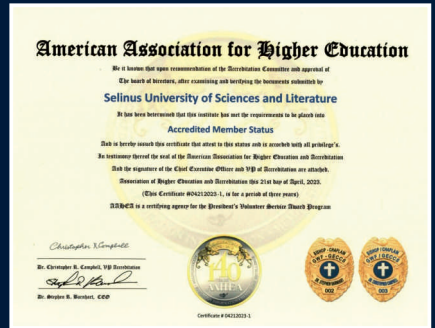

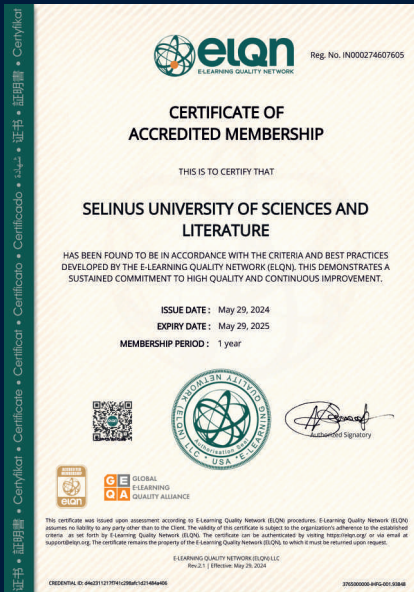

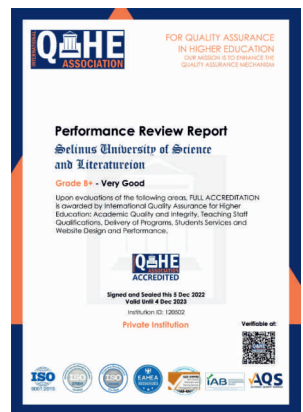
Selinus University has the QAHE accreditation

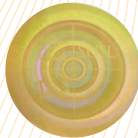
